Overview

Fellows receive a broad education in all aspects of otologic and neuro-otologic care, including management of chronic ear disease, hearing loss/deafness, Meniere's disease, otosclerosis and more. They actively participate in all realms of care—clinic, operating room, and postoperative recovery in the hospital. Surgery volume is high and Fellows are involved in approximately 600 to 800 cases throughout the year(s).



Fellows typically spend the equivalent of six months with Dr. Paparella and six months with our other distinguished faculty, all of whom have completed Fellowships in otology or extensive post-residency training in otology. Because of the practice's unique situation with the International Hearing Foundation and the Department of Otolaryngology at the University of Minnesota, opportunities for both clinical and basic science research are present and encouraged.
